***Agreement to Participate
Eligibility Approval form***

Pleasant Hill Athletics and Cheerleading practices will require vigorous exercise that includes muscular strength, muscular endurance, flexibility, and cardiovascular endurance. All athletes will train at a high level of intensity. The objective of practice is to improve the overall skill level and conditioning of each individual and to assess the individual skills and readiness for interscholastic competition.

Participation can be a dangerous activity involving many risks of injury. The dangers of the sport include but are not limited to: death; serious neck and spinal injuries which may result in complete or partial paralysis; brain damage; serious injury to virtually all internal organs, virtually all bones, joints, ligaments, muscles, tendons, and other aspects of the body; general health and well-being.

I _____, understand that the dangers and risks of playing or practicing in athletics may result not only in serious injury, but in a serious impairment of my future abilities to earn a living, to engage in other business, social and recreational activities and generally to enjoy life.

It is expected that each athlete will follow the rules of the team and follow the directions of all coaches. The program is non-prescriptive, that is participants will be doing exercises as a group with individual objectives. At any time you have the right not to participate in or to discontinue participation in a specific activity with which you do not feel comfortable. While participating in a group activity, you must monitor your own participation.

I agree that I have read all of the above information and understand it completely. I will not hold the school or any of the coaches responsible for failing to instruct me of the dangers of failing to teach proper and safe techniques of the sport in the case of injury, accident, or death. At this time, there is not any known physical reason why I should not be able to participate in Pleasant Hill Athletics and/or Cheerleading team. A private family insurance or company policy against accidents covers me.
