SUMMARY: Assesses students requiring the direct services of a registered nurse.

ESSENTIAL DUTIES AND RESPONSIBILITIES: Other duties may be assigned.

- Train and mentor new and existing health room staff, in accordance with district policies and procedures as they work within the educational setting.
- Provide district wide training on chronic illnesses such as (but not limited to): Asthma; Diabetes; Seizures; Blood Borne Pathogens; Administering Emergency Medicine such as Epi-Pens; Albuterol and Glucagon.
- In Depth training to nurses and secretaries for health room coverage in the absence of the nurse / health room clerk, which would include administering medications, medication policy and procedure.
- Monitor immunizations for the district and submit immunization report to the Department of Health an exemption have received their immunizations and follow up with those currently in the process of receiving immunizations throughout the school year. Ensure immunization records are in compliance.
- Compile a list of illnesses in the district and use the online reporting system to file the Health Survey Summary and Staff Report to the Department of Health and Senior Services on an annual basis.
- Communicate with the Cass County Health Department and the School Administration regarding the possibility of contagious diseases and help formulate a plan to combat it.
- Coordinate a Flu Shot Clinic in the fall for employees. Reinforce education regarding the importance of the flu
- Oversee the Wellness Program and coordinate with district administration to continue program improvements and compliance.
- Coordinate a Wellness Fair in the spring for employees.
- Communicate with nursing staff and administration any information from the Missouri Department of Health and Senior Services regarding school health.
- Assist nurses and administration with issues in other health rooms.
- Perform audits of medication administration and controlled medications in all health rooms.
- Assist in hiring new school nursing staff.
- Attend webinars / seminars to keep up to date with medical issues.
- Review changes in school policies and procedures.
- Provide training and orientation for substitutes.
- Coordinate with Cass Community LPN School for student clinical rotation at the Primary and Elementary Schools.
- Provide professional development for nurses.
- Ensure nurses attend 504 meetings when necessary.
